The undersigned further agrees that if the above said ordinances are not fully complied with in the location, erection, construction and use of the above structure the permit may then be revoked by notice from the County and that then and there it shall become null & void.

The issuance of a permit based upon plans, specifications and other data shall not prevent the Building Official from thereafter requiring the correction of errors in said plans, specifications and other data or from preventing building operation being carried on there under when in violation of this code or any other ordinance or regulations of this Jurisdiction.

The review of the submitted plans and specifications and inspections conducted thereafter does not constitute an acceptance of any responsibilities or liabilities by La Plata County for errors, omissions or discrepancies. The responsibility for these items and implementation during construction rests specifically with the architect, designer, builder and owner. Comments are intended to be constructive and in support of the owner's interests.

This permit become null & void if work or construction authorized is not commenced within 180 days, or if construction or work is suspended or abandoned for a period of 180 days at any time after the work is commenced. I hereby certify that I have read and examined this application and know the same to be true and correct. All provisions of laws and ordinances governing this type of work will be complied with whether specified herein or not. The granting of a permit does not presume to give authority to violate or cancel the provisions of any other State of Local law regulating construction and that I make this statement under penalty of perjury.
